

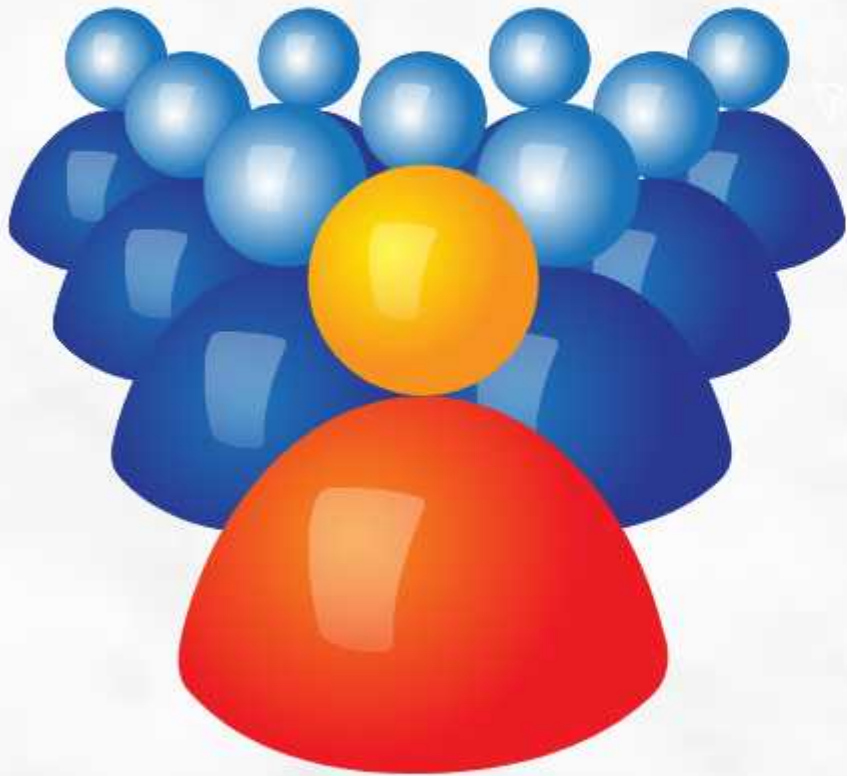

ROI Income

- 1% of the Package amount till 2x of the return.
- 2x includes all incomes. After receiving the 2x income if 90 (as upgrade is allowed after 90 days only) days are not completed then members can do only re-topup in the same package.
- For Example - "A" 85 days are completed and "A" has received the 2x income , now "A" can only do the re-topup in the same package , because upgrade can be done after completion of the 90 days.
- Let's say if in the same example "A" does the re-topup and also upgrades the package after 5 days then "A" will receive the ROI on both of the Packages.
